Disclosure Regarding Academic Curriculum Requirements for Licensure

**Master of Physician Assistant Studies (MSPAS)**

Physician Assistant is a licensed profession in all 50 states. To become licensed to practice as a Physician Assistant in all states, a student must graduate from a program accredited by the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA) and pass the Physician Assistant National Certifying Examination (PANCE) administered by the National Commission on Certification of Physician Assistants (NCCPA). DMU's Master of Science in Physician Assistant Studies (MSPAS) degree program is accredited by ARC-PA. The curriculum is designed to meet educational requirements to apply for PA licensure in every state and graduates are eligible to take the PANCE which is a requirement for initial licensure as a Physician Assistant in the US.

State requirements for licensure are subject to change. These statements and program completion do not guarantee licensure. DMU cannot provide verification of an individual's ability to meet licensure requirements unrelated to its educational program. Students are encouraged to review licensure requirements - including non-educational requirements such as certification/examination, work experience, background checks, etc. - for the states in which they intend to seek licensure.
